LINKING OF CHANDIGARH ON THE MAIN LINE

*303. SHRI JAGAT NARAIN: Will the Minister of RAILWAYS be pleased to state :

(a) whether the Chandigarh Advisory Committee has unanimously recommended to Government to bring Chandigarh on the main line, linking Ludhiana with Jagadhri via Chandigarh;

(b) if so, whether the proposal has been examined by Government; and

(c) the progress made in this regard?

THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA) : (a) Yes, Sir.

(b) and (c) The financial implications of constructing a new railway line between Chandigarh, and Morinda only and then diverting some of the important trains from Ambala to Sir-hind via Chandigarh and Morinda are, at present, being worked out by the Northern Railway and a final decision will be taken when the results of the investigations are known.

PRICE OF RAW JUTE

*304. SHRI N. R. MUN1SWAMY : Will the Minister cf COMMERCE be pleased to state:

(a) the steps taken by the Government to maintain the minimum price of raw jute ;

(b) whether any incentives are being given to the cultivator for augmenting the production of raw jute which has alarmingly come down of late; and
