## IMPORT OF FOREIGN FILMS FROM AMERICA

- 710. DR. (MRS.) MANGLADEVI TALWAR: Will the Minister of COMMERCE be pleased to state:
- (a) whether it is a fact that India has spent 30 lakh dollars for importing foreign films from America during 1967:
- (b) the value of Indian films exported to America during the said period; and
- (c) the names of countries, other than America to which India paid foreign exchange for importing foreign films during the said period together with the details of foreign exchange paid?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI MOHAMMAD SHAFI QURESHI): (a) No, Sir. Foreign Films worth 1.79 lakhs dollars only were imported from U.S. A. during the year 1967.

- (b) Indian films worth 28,000 dollars were exported to U. S. A. during the same period.
- (c) A statement showing the import of films from foreign countries other than U. S. A. for the years 1966-67 and 1967-68 is attached as import statistics are maintained according to the financial year. [See Appendix LXVI, Annexure No. 50.].

- (c) whether these equipments are usually stolen from the railway yards or from the running trains?
