(iii) Heavy Machine Tools Plant.—

This plant commenced pilot production in October, 1966 limited to assembly of O K D components. During the year 1966-67 and 1967-68 total annual production was 7 machines and 15 machines respectively

(c) Hindustan Machine Tools Limited

As a result of recession, there had been a steep fall in demand for machine tools generally and this has in turn affected Hindustan Machine Tools Limited also. Consequently stocks of machines had accumulated and the production had to be restricted to 40-50 per cent of the installed capacity to avoid further accumulation of stocks. While there has been no progress in disposing of the stocks so far, there has been a general improving trend in order position which is expected to ease the stock position also.

Heavy Electricals (India) Limited

Due to recession, the orders for switchgear medium voltage capacitors and thermal generating plant have gone down. This would result in under-utilisation of the capacity available for the manufacture of these items during the next two or three years. In almost all cases, manufacture is undertaken only against specific orders in view of the custom-built nature of the equipment. Hence there has been no accumulation of stock.

Heavy Engineering Corporation Limited

The recession cannot be said to have directly affected Heavy Machine Building and Foundry Forge Plants so far. This is due to the fact that the capacity is being built up and production at present is in the initial stages as also the fact that the manufacturing cycle of Heavy Machine Building Plant is fairly long. Only the Heavy Machine Tools Plant which is also in the early production stage has not been able to procure sufficient orders for certain models of machine tools, owing to the recession. Till the end of March '68, 8 number of machine tools valued at about Rs 37 lakhs were lying unsold in stock.

APPOINTMENT OF A MARKETING OFFICER IN HONG KONG
