The question of providing standing type choolas is under examination.

VENTILATION IN KITCHENS OF GOVERNMENT **OUARTERS**

792. CHAUDHARY A. MOHAMMAD: SHRI B. D. KHOBARAGADE :

the Minister of WORKS, HOUSING AND SUPPLY be pleased to state:

- (a) whether it is a fact that the work of providing proper ventilation in the kitchens of Government residential quarters Nos. 378 to 396 Lakshmi Bai Nagar, New Delhi, has been pending for the last two years or so since it was brought to the notice of Government by the residents; and
- (b) if so, what are the reasons for the delay?

THE DEPUTY MINISTER IN THE MINISTRY OF WORKS, HOUSING, AND SUPPLY (SARDAR SINGH): (a) and (b) Government accepted the necessity for this work and issued administrative approval and expendituresanction in April, 1968. The detailed estimate has since been technically sanctioned by the concerned Executive Engineer and he has already invited tenders. The work is expected to be taken up shortly, and completed within a couple of months.

THE DEPUTY PRIME MINISTER AND MINISTER OF FINANCE (SHRI MORARJI R. DESAI): (a) and (b) The All India Insurance Employees' Association has issued a call to Class III and Class IV employees of the Corporation to go on an indefinite strike from 5th December, 1968 on the issues of (i) automation (ii) Charter of Demands and other pending questions and (iii) alleged victimisation of the active workers of the Association, and has served a notice on the L.I.C. to this effect.

- (c) Government appointed on 28th November, 1968 a National Industrial Tribunal to adjudicate on the following matters:—
 - 1. Revision of the scales of pay of different categories of workmen
 - 2. Revision of dearness allowance.
- 3. Grant of special pay to certain categories of workmen;
 - 4. Payment of other allowances;
 - Revision of the existing provident fund, pension and gratuity schemes; and
 - 6. Medical benefits.

On other matters, it is for the L.I.C. to take such steps as they consider appropriate.

These irrigation schemes are getting central assistance through the miscellaneous development loans which are advanced to the State Government for the State Plan as a whole. None of these schemes is getting ear-marked central assistance except that during 1965-66 additional central assistance of Rs. 110 lakhs was given for 6 irrigation projects in Kerala, namely. Neyyar Stage I & II. Pothundy, Chitturpuzha, Perivar Valley, Gayatri and Pamba, to accelerate their construction with a view to realizing irrigation benefits earlier.
