- (b) Any programme of construction, depends on factors like financial resources availability of land etc. It is, therefore. not possible to say how long it would take to provide residential accommodation to all the Government servants working in eligible offices.
- (c) and (d) Government is examining a proposal, subject to availability of resources, for the construction of residential accommodation so as to provide accommodation to a reasonably adequate number of their employees within the next few years.

SHORTAGE OF PETROL IN CALCUTTA

- (a) whether the attention of Government has been drawn to the news item in the Hindustan Times dated the 13th November, 1968 to the effect that because of a dispute between the management and employees of some foreign oil companies, Calcutta is facing acute shortage of petrol;

MINISTER OF STATE IN THE THE MINISTRY OF PETROLEUM CHEMICALS (SHRI K. RA-AND GHURAMAIAH) : (a) Yes, Sir.

(b) During the period of the strike by the staff of the private oil comparies, emergency measures were taken by the Indian Oil Corporation to meet the public requirements for motor spirit (petrol) and high speed diesel oil through its own retail outlets in the Calcutta area. As a result of the initiative taken by the Government, the strike has since ended and the supply position has become normal.

The proposal is under consideration.
