DESAI): (a) and (b) On 30th June 1968 the Superintendent of Central Excise, Agra seized 3795 kgs. of tobacco stalks at village Sonai in Mathura District as it was not covered by any valid transport permit as required under Rule 32 of the Central Excise Rules 1944. The case has been adjudicated by the Assistant Collector of Central Excise, Agra who has confiscated the tobacco stalks with an option to the patty to pay a fine of Rs. 250 in lieu of such confiscation; further a penalty of Rs. 250 has also been imposed on the party concerned.]

## PURCHASE AND STANDARD OF CONDOMS
