THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) Yes, Sir.

DREDGING IN PARADELP PORT

811. SHR1 BANKA BEHARY DAS: Will the Minister of TRANSPORT AND SH1PPING be pleased to state:

- (a) how far the proposal of dredging in Paradeep Port—as recommended by the Sukrani Committee has progressed; and
- (b) by when the work will be under taken and when it will be completed?

THE MINISTER OF TRANSPORT AND SHIPPING (PROF. V.K.R.V. RAO): (1) and (b) The Icam of Experts which examined the Siltation problem at Paradip had suggested some immediate remedial measures and some long-term remedies. Pursuant to the recommendations concerning immediate remedical measures, dredgei 'Mohana' of the Calcutta Port Commissioners was deputed to work at Paradip Port; the guarantee dry-docking repairs of the Fort's own maintenance dredger 'Konarka' were expedited and it was also fitted with a nozzle to facilitate stationary dredging. A craft of 35 ft. with LOA of 635 ft. has been restored on the 30th November, 1968. Steps have also been taken to obrain dreger Visakha from the Visakhapatnam Port Trust to dredge the shoal. She is expected to arrive at Paradip by about the 25th December 1968

The long term recommendations relate to the provision of sand traps at the entrance in the vicinity of the Southern Breakwater and in the south of the entrance channel as also the widening of the turning circle so as to permit ships of 60,000 DWT. A Dutch firm and a Japanese firm have submitted their offers for this dredging on a contract basis. The Dutch firm has since withdrawn its offer. The offer of the Japanese firm is being examined by Government.
