GOVERNMENT BUILDINGS BURNT IN NAGALAND

SHRI KRISHAN KANT: SHRI D. THENGARI:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that on the 8th August, 1968 officials from the Sibsagar District of Assam accompanied by Armed Forces illegally burnt Nagaland Police Post buildings worth over Rs. 50,000 (Rupee fifty thousand) at Yachang inside Nagaland;
- (b) whether it is a fact that on the 19th August, 1968 Assam officials from the Sibsagar District of Assam accompanied by Armed Forces entered into Nagaland and burnt 2 Government buildings worth Rs. 5,000 (Rupees five thousand) and 26 village-houses and granaries and standing crops of inestimable value; and
- (c) if so, what action the Union Government propose to take to avoid such situations arising in future?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) and (b) Reports of these incidents have been received from the Government of Nagaland.

(c) The Chief Secretaries of Assam and Nagaland have since discussed this matter on 8th October, 1968 and reached an agreement on steps to be taken to reduce tension and to determine on the ground in certain sectors the border between the two States as defined in the State of Nagaland Act, 1962.

- (ग) क्या यह सच है कि जिस चोर को पिछले वर्ष विजीलेंस किमश्तर के घर पर चोरी करते हुए पकड़ा गया था उसे छोड़ दिया गया है; उसके द्वारा किन-किन स्थानों पर चोरियां की गयी थी और क्या उन लोगों को जिन्होंने उसे पकड़ा था कोई पुरस्कार ये गये है और यदि नहीं, तो उसके क्या कारण हैं?

†[THEFTS COMMITTED IN THE CAPITAL

868. SHRI SURAJ PRASAD: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the number of thefts committed in the capital during 1967-68, the number of persons caught red-handed and the number of policemen who were involved in these thefts;
- (b) the details of the awards given to the persons who had caught the thieves red-handed; and
- (c) whether it is a fact that the theif who was caught last year while committing theft at the residence of the Vigilance Commissioner has been set free, the details of the places where thefts were committed by him and whether the persons who had caught him have been given any awards, if not, the reasons therefor]?

गृह-कार्य मंत्रालय में राज्य मंत्री(श्री विद्या चरण शुक्ल) : (क) 1-1-1967 से 15-11-1968 तक की अवधि में राजधानी में चोरी के 18,866 मामले धूचित किए गये थे। इन मामलों में 1,281 व्यक्ति रंगे हाथी पकड़े गये। बताया जाता है कि चोरी के कुछ मामलों में दो पूलिस कर्मचारियों का भी हाथ था।
