### Consulate General of India at Birgunj:

31. Responding to the long-standing indian request for the setting up of the Consulate General of India at Birgunj, the Nepalese side informed that the request was under consideration of His Majesty's Government.

#### Invitation:

32. The Prime Minister of Nepal invited the Prime Ministers of India to pay an official visit to Nepal an early date. The invitation was accepted with pleasure. The dates of the visit would be decided through diplomatic channels.

# Transfer of Chinese Missile Technology to Pakistan

- 3340. SHRI K. C. KONDAIAH: Will the Minister of EXTERNAL AFFAIRS be pleased to state:
- (a) whether during the visit of Chinese Foreign Minister, Government took up the matter with regard to transfer of Chinese Missile Technology to Pakistan;
  - (b) if so, details of discussion therefor; and
  - (c) the outcome thereof?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI AJIT KUMAR PANJA): (a) to (c) Yes, Sir. Our concerns on Sino-Pakistan military cooperation, which includes cooperation in the field of missiles, were reiterated. China maintains that it has normal state-to-state relations with Pakistan including normal military co-operation and that Sino-Pakistan cooperation was not target against any third country.

THE MINISTER OF PARLIAMENTARY AFFAIRS AND MINISTRY OF INFORMATION TECHNOLOGY (SHRI PRAMOD MAHAJAN): (a) to (d) Several countries including USA, UK, Italy, Germany, Ireland, Japan, China and Singapore have evinced keen interest in utilising the services of Information Technology professionals from India. The Government has not placed any restriction on their movement to other countries.

Meantime, the Government has on 7th August, 2000 constituted a Task Force to prepare a long term strategy for human resouce development in the area of Information Technology.
