## FINANCIAL AID TO TEA ESTATES

798 SHRI G BARBORA Will the Minister of COMMERCE be pleased to state

(a) whether it is a fact that there are Tea Estates in India which are uneconomic or just marginal because of their less acreage of plantation and less p'oduction capacity, and

(b) if so, whether the Government of India have any suitable machinery to give financial aid and concessions from Excise and other taxes to such Tea Estate?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI MOHD SHAFI QURESHI) (a) Tea Estates become uneconomic or marginal due to various factors such as high costs, low quality, inefficient management and lack of up-to-date know-how, and not due solely to size of tea estates

(b) There is no Scheme for giving hnancial aid and concessions from excise and other taxes exclusively to tea estates having less acreage or less productive capacity, but the estates with lower productivity resulting from overaged tea bushes will benefit from the replantation loan and subsidy schemes of the Government, being implemented through the Tea Board.
