SPEECHES MADE BY CENTRAL LAW MINISTER IN KERALA

- (a) whether the attention of Government has been drawn to the reported public speeches made by the Union Law Minister in Kerala condemning the United Front Government of Kerala; and

THE MINISTER OF HOME AFFAIRS (SHRI Y. B. CHAVAN): (a) The Chief Minister, Kerala has complained that the Law Minister had made certain speeches which were, in his view, objectionable, provocative and constitutionally improper.

(b) In a recent letter to the Chief Minister. the Law Minister has summarised the burden of his speeches. The main point he made was that the Marxists and those under their influence were indulging in lawlessness in '

Kerala, and that the responsible authorities of the State Government did not come forward to check their activities under the law. In the circumstances, according to the Minister, the people had no way but to organize themselves to protect their property, lives and honour. The Law Minister stated that there was no incitement for revolt against the elected Government in the State.
