INABILITY OF PRIVATE SECTOR COALCOMPANIES TO PRODUCE IN FULLCAPACITY

the production of coking coal has been more or less keeping pace with the demand. It would, however, be necessary for the private sector coal companies holding huge reserves of coking coal in the middle zone of the Jharia coalfields which contains the best part of the economically mineable reserves to increase their production to meet the requirements of the metallurgical users during the IV Plan period and they are being advised accordingly.

NAGPUR-CHANDA FORT LINE ON SOUTH EASTERN RAILWAY

- 1144. SHRI V. T. NAGPURE: Will the Minister of RAILWAYS be pleased to state:
- (a) the reasons for the abrupt discontinuance of diesel engines on the Nagpur-Chanda Fort line on the South Eastern Railway; and
- (b) the number of stations on that line which are without proper drinking water arrangements, electric lights, telephones and platforms?

THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA): (a) Only

- a limited number of diesel engines are available on the Narrow Gauge section of South Eastern Railway and these are to be utilised on the sections where goods services are the maximum. Dieseli-sation of Nagpur-Chanda section had to be discontinued on account of meagre goods traffic due to drop in the traffic in bamboos moving for Balharshah Paper Mills *via* Chanda Fort. These diesel locomotives were transferred to Chindwara section where services are much heavier.
- (b) All stations on the Nagpur-Chanda Fort line are provided with drinking water arrangements. Seven stations" are not provided with electric lights. Telephones are not provided at 11 stations. All stations are provided with rail level platforms.
