**THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED) :** (a) and (b) Yes, Sir. The National Small Industries Corporation proposed to set up an Exhibition and Export Promotion Division, for small-scale industries to be financed by Government by payment of Rs. 15 lakhs as interest free loan, in addition to an annual grant of Rs. 5 lakhs for a few years.

(c) The matter is under consideration.

#### **AGREEMENT WITH KENYA FILM CORPORATION FOR EXPORT OF FILMS**

**1162. SHRI B. C. PATTANAYAK :** Will the Minister of COMMERCE be pleased to state :

(a) the number of films sent so far under the agreement reached between the Indian Motion Pictures Export Corporation Ltd. of India and the Kenya Film Corporation ;

(b) the time by when the above agreement would be implemented by the Government ; and

(c) the foreign exchange likely to be earned during the year ?

**THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI MOHD. SHAFI QURESHI) :** (a) So far no film has been exported in terms of the agreement but three black and white pictures, valued at Rs. 26 500 are expected to be shipped in a week's time.

(b) The Government of India is not a party to the agreement. The agreement is, however, for a period of 5 years with effect from 1st July, 1968.

(c) A sum of Rs. 14 lakhs is expected to be earned by the Indian Motion Pictures Export Corporation during the current financial year. This amount includes sale of films to Kenya both in terms of the agreement as well as prior to the agreement.

#### **NEWSPRINT FACTORY IN U.P.**

**1163. SHRI B. C. PATTANAYAK :** Will the Minister of INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS be pleased to State :

(a) whether it is a fact that a newsprint project will be set up in U.P. with the assistance of some foreign countries ;

(b) whether any site has been selected ;

(c) if so, the names of the countries and the firm of assistance likely to be provided by these countries ; and

(d) by what time the project would be completed ?

**THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED) :** (a) No, Sir.

#### **PAY FIXATION OF EMPLOYEES ON PROMOTION IN RAILWAYS**

**1164. SHRI M. P. BHARGAVA :** Will the Minister of RAILWAYS be pleased to state :

(a) the basic principles and the categories in which special pay is taken into consideration for fixation of pay on promotion to higher posts on the Indian Railways ;

(b) the number of cases in different categories entitled to special pay on promotion from lower to higher post and from Class III to Class II on each of the Zonal Railways during the last three years, in which special pay was not merged while fixing the pay on promotion to higher post ;

(c) whether representations have been received that the special pay granted to Steno-typists utilised as Stenographers and to Stenographers attached to Heads of Departments should not be treated differently for purposes of fixation of pay on promotion to higher posts ; and

(d) if so, the action taken thereon ?

**THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA) :** (a) Special Pay is taken into consideration for fixation of pay on promotion to a higher post, provided it is granted in

lieu of a higher scale of pay than the pay of the post, subject to the condition that such special pay has been drawn in the lower post continuously for a minimum period of 3 years on the date of promotion. In accordance with this criterion the categories in the Railways, which are entitled to special pay being taken into consideration for fixation of pay on promotion are as follows :—

- (1) Wireless Operators.
  - (2) Shop Superintendents.
  - (3) Steno-typists and Hindi/English Typists utilised as Stenographers in cases where full time Stenographers are not justified.
  - (4) Deputy Directors of the Railway Board belonging to the Railway Board Secretariat Service.
- (b) Information is being collected and will be laid on the Table of the Sabha in due course.
- (c) No representations have been received from Steno-typists utilised as Stenographers in view of the fact that their special pay is already taken into account for fixation of pay on promotion. Representations have, however, been received from Stenographers attached to Heads of Departments on this matter.
- (d) It has been decided that no revision of the list of categories entitled to consideration of special pay for fixation of pay on promotion to higher posts would be justified.

#### TRANSFER OF RAILWAY EMPLOYEES IN NAGPUR DIVISION, CENTRAL RAILWAY
