LATE RUNNING OF THROUGH CARRIAGE FROM POONA TO NAGPUR

28. SHRI J. S. TILAK: Will the Minister of RAILWAYS be pleased to state the number of days on which the through carriage which runs daily from Poona to Nagpur ran behind schedule during the past twelve months?

THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA): During the twelve months November 1967 to October, 1968 the Poona-Nagpur through sleeper coach via Manmad did not run by the scheduled train (29 Dn. Express) ex. Manmad to Nagpur on a total of 161 days.

DISRUPTION OF RAIL TRAFFIC DUE TO FLOODS

- (e) whether there is any proposal under the consideration of Government to reduce the price of the scooter which is very heavy at present?

THE MINISTER OF INDUSTRIAL EVELOPMENT AND COMPANY DEVELOPMENT AFFAIRS (SHRI FAKHRUDDIN ALI AHMED): (a) Government have decided to license one new unit of a suitable economic capacity to fill the existing gap between the supply demand.

- (b) The new unit will be in the private sector.
- (c) The new unit may be expected to go into production in about two years after it is licensed.
- (d) The names of the units with their installed capacities which are manufacturing scooters at present are given below :-
