(a) the progress so far made with regard to the proposal for the manufacture of agricultural tractors by Ms. Ghaziabad Engineering (P) Ltd. in collaboration with M/s. Brommash Export of Moscow;

(b) the capital investment involved; and

(c) the extent to which the Central Government are a party to this venture by a private firm?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED): (a) The proposal submitted by M/s. Ghaziabad Engineering (P) Ltd. for the manufacture of DT-14B tractors in collaboration with M/s. Prommasheexport and Tractor-export of USSR has been examined and the views of Government in regard to the proposed terms of foreign collaboration and the phased manufacturing programme have been communicated to them. They have been asked to submit their application for the import of plant and equipment required for implementing the project.

(b) About Rs. 7 crores.

(c) This project is being set up in the private sector and the Central Government are not participating in this venture.

BALANCE OF TRADE BETWEEN INDIA AND FOREIGN COUNTRIES

*11. SHRI JAGAT NARAIN: Will the Minister of COMMERCE be pleased to state :

(a) whether the balance of trade between India and foreign countries during the months of January and September, 1968 has been favourable; and

(b) if not, the value of excess imports over exports?

THE MINISTER OF COMMERCE (SHRI DINESH SINGH): (a) No, Sir. However, the adverse balance of trade gap has been reduced from Rs. 31.75 crores in January, 1968 to Rs. 15.23 crores in September, 1968.

TRACTOR FACTORY IN PUBLIC SECTOR

13. SHRI S. K. VAISHAMPA-YEN : Will the Minister of INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS be pleased to refer to the reply to Unstarred Question No. 724 given in the Rajya Sabha on 5th August, 1968 and state the progress so far made with regard to the proposal to set up a factory for the manufacture of small tractors of 10/15 H.P. in Public Sector ?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED) : The proposal is to set up a project for the manufacture of 20' H.P. tractors. The feasibility report received from the Czechoslovakian Agency for the manufacture of the Zetor 2011 tractor has been examined. In the meantime the Hindustan Machine Tools Ltd. and the Mining and Allied Machinery Corporation, Durgapur have put up a joint proposal to utilise the spare capacity available with them for setting up the manufacture of either the Czech tractor or another tractor which has been designed and is being developed by the Mining and Allied Machinery Corporation in collaboration with the Central Mechanical Engineering Research Institute, Durgapur.
