the authority to give shops, godown plat-forms etc. on rent. The Fruit and Vegetable Market was transferred to the Delhi Municipal Corporation with effect from 1st April, 1959. The Corporation have not yet entered into any lease agreement with the Fruit and Vegetable Merchants Union. The Union is resisting in a Court of Law the payment of tehbazari to the Corporation. The case is sub-judice.
