

†[THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION (PROF. SHER SINGH) : Yes, Sir. The recommendations of the Education Commission were examined in detail at various levels and out of these discussions was evolved a National Policy on Education, on which a Government Resolution was issued and laid on the Table of the House on 24th July, 1968.

The implementation of this Policy is largely a responsibility of the State Governments. Both the Central and State Governments are trying their best to implement it in the Fourth Five Year Plan to the extent resources are available.]

‡NORTHEAST FRONTIER RAILWAY EMPLOYEES KILLED BY POLICE FIRING

1004. SHRI G. BARBORA : Will the Minister of HOME AFFAIRS be pleased to state :

(a) whether it is a fact that two employees of the Northeast Frontier Railway died as a result of firing resorted to by the police on strikers on the 19th September, 1968 at Mariani and Bongaigaon ;

(b) if so, whether any enquiry has been made into the causes of the police firing ; and

(c) whether any compensation has been paid to the members of the families of the said two persons ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA) :

(a) Of the two persons killed at Mariani as a result of police firing on September 19, 1968, one was a railway Khalasi. The facts regarding the firing at Bongaigaon are being ascertained from the State Government.

(b) The State Government have ordered a judicial inquiry into the incidents at Mariani. Information about Bongaigaon is being collected.

(c) Facts are being ascertained.
