(a) the names of the villages on the Indo-Pak border of Jaisalmer and Barmar districts near which twelve solitary huts which have been discovered are situated and what is the population of each of them;

(b) what is the number of villages, out of 154 villages reported to be situated on this portion of the border which are located upto a distance of ten miles from the border and what was the population of each of these villages at the end of the years 1966 and 1967, respectively; and

(c) what was the population of these 154 villages in the middle of November, 1961 and how many of them are Hindus and how many are Muslims?]

COLLECTION OF ARREARS OF RENT FROM FRUIT AND VEGETABLE MARKET, DELHI

*657. SHRIMATI SARLA BHADAURIA : Will the Minister of HOME AFFAIRS be pleased to state :

(a) whether it is a fact that Government have to collect arrears of rent amounting to Rs. 42 lakhs from the allottees of the Fruit and Vegetable Market, Delhi; and

(b) if so, what steps are being taken for recovery under the Public Premises (Eviction of unauthorised occupants) Act, 1958?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA) : (a) and (b) The ownership of Fruit and Vegetable Market vests in the Delhi Municipal Corporation from 1st April, 1959. The claim of the Corporation in respect of tehbazari against the Fruit and Vegetable Merchants Union who in 1943 had obtained the Market from the Delhi Improvement Trust on lease, has been challenged in a Court of Law. The case is at present sub-judice.

COMMISSION FOR SCIENTIFIC AND TECHNICAL TERMINOLOGY

*658. SHRI G. BARBORA : Will the Minister of EDUCATION be pleased to state :

(a) whether it is a fact that the office of the Commission for Scientific and

Technical Terminology was shifted twice during the last nine months ; and

(b) if so, whether any estimate has been made of the losses due to breakage or missing of articles during such shifting ?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION (PROF. SHER SINGH) : (a) Only the Publication Unit of the Commission for Scientific and Technical Terminology has been shifted twice during April/May, 1968 and October, 1968.

(b) No appreciable loss on account of breakage or missing of articles has occurred during the shifting.

(c) what steps have been taken with a view to preventing recurrence of such incidents ?]

(ग) केन्द्रीय सुरक्षा संगठनों, राज्य सरकारों और संघ राज्य क्षेत्रों द्वारा आवश्यक सतर्कता बरती जाती है ।

(b) On the basis of information received from all the States and Union Territory bordering Pakistan, other than Assam and Jammu & Kashmir, the number is 101 for Rajasthan and none for others. Information from the above mentioned two States is awaited and on receipt of the same will be placed on the Table of the House.

(c) Necessary vigil is being maintained by the Central Security Organisations and the State Governments and Union Territory in this regards.]
