- (i) Linking of the dearness allowance to the cost of living index;
- (ii) Ad hoc increases in dearness allowance:
- (iii) House Rent Allowance at a flat rate of 12½ per cent. of the basic pay for Development Officers drawing Rs. 500 or more without verification of rent paid;
- (iv) Bonus at the rate of 11 months' salary.
- (c) The Life Insurance Corporation and the National Federation of Insurance Field Workers have agreed to refer the matter to Government for an "appropriate and just" decision. The Government is expected to give its decision on the matter very soon.
