(ग) पश्चिम कोसी नहर दिसम्बर, 1966 के सशोधित कोसी समझौते का एक अंग बन चुकी है।

†[THE MINISTER OF IRRIGA-TION AND POWER (DR. K. L. RAO): (a) and (b) Western Kosi Canal Project is an approved scheme of the Third Plan. The first 22 miles of the Canal pass through Nepal. The Project could not be taken up for construction so far, as approval of the Government of Nepal for the alignment in their territory has not yet been received.

(c) The Western Kosi Canal forms already a part of the Revised Kosi agreement of December, 1966.
