†[THE MINISTER OF DEFENCE (SARDAR SWARAN SINGH): (a) to (c) Although earlier a larger number of ex-NCC cadets were taken into the IMA, since 1966 arrangements have been made for 32 ex-NCC cadets to be admitted into the IMA, so that, after allowing for wastage, an output of 30 Commissioned officers is ensured.

(a) whether Government are aware that an agreement has been reached between Pakistan and China for border trade between Pakistan occupied part of Kashmir and Sinkiang;

- (b) whether Government are aware that the road through which the trade is supposed to be conducted is not a commercial road but a strategic one; and
- (c) if so, reaction of Government in regard thereto?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI B. R. BHAGAT): (a) Yes, Sir. This agreement was reached in October, 1967.

(b) and (c) Yes, Sir. In our protest notes to the Governments of Pakistan and China, copies of which were laid on the Table of this House on May 13, 1968, we have pointed out that in the light of the known back-ground of Sino-Pak collusion and Pakistan's persistent efforts to seek Chinese military support against India, the purpose of the agreement is obviously not merely trade.

CENSOR OF FILM 'SPY IN ROME'

- (a) whether Government's attention has been drawn to the film 'Spy in Rome' wherein India have been called fools; and
- (b) if so, the circumstances in which the film was passed by the Censors and the action Government propose to take in the matter?

THE MINISTER OF INFORMATION AND BROAD CASTING (SHRI K. K. SHAH): (a) Yes, Sir, through a press comment which appeared in 'Shravya Drishya Kalayen' column of Nagpur Bulletin (a Hindi Fortnightly) criticising the dialogue 'Isi liye Hindustan ko bewaqoofon ka mulk kaha gaya hai, occuring in the film 'Spy in Rome'.

(b) The dialogue in question is spoken out of frustration by villain, an enemy of India, for the Indian scientist who does not yield to temptation to disclose the secret formula and undergoes tortures at the hands of the villain. The Intent and purpose of the dialogues is to bring out by contrast the good quality of an Indian scientist against the viles of a villain. No action is therefore, proposed be taken by Government.

Will the PRIME MINISTER be pleased to state whether Government propose to take some steps to ease tension between Malaysia and Philippines over the Sabah issue in order to ease the situation in South East Asia?

Members will appreciate that in the context of tension over the delicate situation when both sides are actually engaged in negotiations, it will not be desirable to give public expression to our views on this issue.
