## REVERSION OF POLICE OFFICERS IN DELHI

- 148. SHRI T. SIDDALINGAYA: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that some police officials of the Delhi Administration have recently been reverted to their substantive ranks;
- (b) if so, the number and ranks of such officers;
- (c) the reasons for their reversion to substantive posts; and
- (d) whether they were given an opportunity to plead their cases before they were reverted?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) and (b) During the period from 15-8-1968 to 15-11-1968, the following police officials of the Delhi Administration were reverted to their substantial ranks:

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) No, Sir.

- (c) Indian Airlines have reported that proprietory or restricted items of stores are obtained direct from the manufacturers. Other items are purchased after inviting tenders/quotations.

PURCHASE OF TU 134 AIRCRAFT FROM RUSSIA

- 150. SHRI KRISHAN KANT: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:
- (a) whether Government have received details about the new aircraft TU-134 proposed to be acquired from Russia for operating them by the Indian Airlines;
- (b) if so, the terms and conditions under which they are proposed to be acquired; and
- (c) to what extent this is economical in its performance as compared to Boeing 137?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) to (c) The Indian Airlines had obtained particulars of TU-134 aircraft while conducting a study of suitable aircraft for augmenting their fleet. They have not recommended the purchase of TU-134 as the profit potential of this aircraft is comparatively low.
