#### STATEMENT

According to information furnished by the State Government, on September 8, 1968, at about 1 A.M. one Shri Biswanath Chowdhry, a student aged about 22 years and reported to be a worker of CP(M), is alleged to have been attacked by some persons of the opposite party. Shri Biswanath Chowdhry was at that time writing election slogans on the wall in a lane in Belia-ghata police station. Serious injuries were inflicted on him and he was removed to hospital where he succumbed to his injuries. Three of the four accused persons, mentioned in the dying declaration, have been arrested and all-out efforts have been made to apprehend the other culprit. (The names of the arrested persons are being ascertained). The case is being investigated by the Detective Department of the Calcutta police.

2. The State Government are being advised to ensure that the investigation of the case is expedited and to take appropriate action under the law to prevent violence in connection with the approaching elections.
