VACANCIES NOTIFIED TO EMPLOYMENT **EXCHANGES**

168. SHRI B. K. GAIKWAD : Will the Minister of HOME AFFAIRS bepleased to state:

- (a) whether it is a fact that while notifying the vacancies to the Employment Exchanges some of the Central establishments do not Government of specify the number vacancies reserved for the Scheduled Castes and the Scheduled Tribes candidates;

- (c) what action Government have taken against such establishments?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI K. S. RAMASWAMY): (a) to (c) In 1955 the Ministry of Home Affairs prescribed a standard requisition form for use by all Central Government establishments for notifying vacancies to Employment Exchanges. In the standard requisition form, there is a specific provision for indicating whether the vacancy, for which the requisition is being placed on the Employment Exchange, is reserved for Scheduled Castes and Scheduled Tribes or whether it is an unreserved vacancy. point was inter alia reiterated in the instructions issued by the Ministry of Home Affairs on the 10th April, 1968. Thereafter no instance of non-compliance by any Ministry/Department/ Office of the Government of India of the orders referred to above in respect of vacancies in the Ministry/Department/Office has come to the notice of the Ministry of Home Affairs.
