MINISTER OF DEFENCE (SARDAR SW ARAN SINGH): (a) and (b) Pakistan continues to encourage the hostile elements ia the eastern sector by supplying them arms and imparting military training. There is as yet no indication that these hostile elements have been associated with training exercises of the Pakistan Army units. Government however keep a close watch on these developments and take necessary steps to deal with them.

THE **PRIME** MINISTER AND MINISTER OF **EXTERNAL** AF (SHRIMATI **FAIRS** INDIR A (a) 21 Czech nationals GANDHI) applied to the Foreigners Regional Re gistration Officer, New Delhi for grant of exist permits to leave India..

(b) This group of Czech nationals consisted of seven technicians and their families. The technicians were working in the Foundry Forge Project of the Heavy Engineering Corporation Limited, Ranchi. They applied for grant of exist permits on 4th October, 1968. while holidaying in Delhi. Their decision to leave India was, as stated by them, due to the political situation in their country. After being satisfied that the persons wanted to leave India of their own accord. Government decided to grant them exit permits since they had indicated their firm intention to proceed to Canada and they held valid Czech passports. They left India by air for Canada on 9th October 1968.
