Will the PRIME MINISTER be pleased to state :

(a) whether any further date has been fixed for holding talks with hostile Nagas;

(b) whether there is a move by the Pro-Phizo section of Nagas to have a round table conference with Government; and

(c) whether Government had refused to have any further talks with the Naga hostiles ?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) to (c) The Naga Public Conference which was held from the 22nd to the 24th August, 1968, passed a resolution suggesting the resumption of talks between the Government of India and the Naga National Council in asso-

ciation with 'Naga leaders of Public Confidence'.

There is no proposal to hold talks with the Underground Nagas at present.

REFUSAL OF THE ENTRY OF INDIAN POLICEMEN BY PAKISTAN

*98. SHRI CHITTA BASU : Will the PRIME MINISTER be pleased to state :

(a) whether it is a fact that Pakistan refused to allow Indian Policemen to enter the Indian enclaves within her territory in the recent past; and

(b) if so, what action has so far been taken by the Government to ensure security for the Indian citizens in the Indian enclaves ?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI B. R. BHAGAT) : (a) and (b) The Government of Pakistan have agreed to the posting of an Indian police party in the Indian enclave of Salbari in exchange for Government of India's agreement to the replacement of the existing police party in the Pakistani enclave of Dahagram.

COMMON ADVISORY COMMITTEE FOR FILM INSTITUTE OF INDIA AND NATIONAL FILM ARCHIVES
