REJECTION OF DR. KHURANA'S APPLICA-TION BY I.A.R.I.

- (a) whether it is a fact that the Nobel Prize winner, Dr. Khurana had applied for carrying out research work in the Indian Agricultural Research Institute and his application was rejected: and
- (b) if so, what were the reasons therefor and what steps have been taken by Government to check the recurrence of such incidents?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE): (a) and (b) Recruitment to all Class I and II Posts under the Indian Council of Agricultural Research and the Indian Agricultural Research Institute was being made through the Union Public Service Commission till 31-3-1966. The question of Dr. Khurana submitting any application to the Indian Council of Agricultural Research or the Indian Agricultural Research Institute and its rejection by these organisations does not, therefore, arise. After 1-4-1966 the Indian Council of Agricultural Research has made its own arrangements to fill such posts. Dr. Khurana has not submitted any application for any research post after that date.

From a News Item appearing in the Times of India in its issue dated the 18th October, 1968 it, however, appears that Dr. Khurana had applied for the Ulass II post of an Assistant Organic Chemist in the Indian Agricultural Ee-iearch Institute but did not succeed in letting the same. From the records

available in the Department of Agriculture it is observed that 2 posts of Assistant Organic Chemist in the Indian Agricultural Research Institute were filled through the Union Public Service Commission in 1951. It hap not been possible to verify whether Dr. Khurana had applied for these posts or not as the relevant file of the Union Public Service Commission has since been destroyed.
