## SHOOTING INCIDENT NEAR AMRITSAR BORDER

- 532. SHRI M. ASAD MADANI: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether Government have received report regarding the shooting incident of the son of Qazi Syed Karimuddin, ex-M.P. (Rajya Sabha) by the Border Security Police along the Amritsar border in September last resulting in his death;
- (b) the circumstances in which the boy was shot at; and
- (c) whether any enquiry has been conducted in this case, if so, what are the findings thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) to (c) According to a report received from the Border Security Force authorities, on the night of the 12/13th August, 1968, two unidentified intruders from the Pak side of the Punjab-West Pakistan border opened fire, on being challenged by a Border Security Force Naka Party. The Naka Party returned self-defence and one intruder fire in dropped dead, while the other one ran to the Pak side. The dead body was disposed of by the local police and was

later identified as that of Kazi Nurruddin Javed, A case has been registered and a magisterial inquiry is also being conducted into the cause of the death of the said Kazi Nurduddin. Findings of the magisterial inquiry are awaited.

#### INDIAN ADMINISTRATIVE SERVICE

- 533. SARDAR RAM SINGH: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that against the authorised strength of 3035 Officers, the Indian Administrative Service is presently manned by 2580 Officers only; and
- (b) whether the gap has arisen as a result of fall in the recruitment to this grade of Officers; and if so, the reasons therefor?

# THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA):

- (a) The Indian Administrative Service is presently manned by 2,637 officers against the authorised strength of 3058.
- (b) No, Sir. From a strength of 2575 in 1966, the strength has risen to 3053 in 1968, partly due to the creation of a new cadre for Nagaland, extension of the Delhi-Himachal Pradesh cadre to the other Union Territories and the normal expansion of cadres in the other States. The gap is mostly due to this increase in the cadre strength during the past few years.
