THE DEPUTY MINISTER IN THE MINISTRY OF TRANSPORT AND SHIPPING (SHRI BHAKT DARSHAN): (a) and (b) Reports show that N. H. No. 5 has been breached at 21 points over a total length of about 4000 feet; and ten minor bridges and thirty culverts have either collapsed or have been so severely damaged as to necessitate reconstruction. About a 22 mile length of the Highway was overtopped by flood waters, thereby eroding the road flanks and damaging the road crust at many places.

- (c) and (d) Additional funds to the extent of Rs. 40 lakhs have been sanctioned for repairs during 1968-69; and a sum of Rs. 12.7 lakhs will be provided to the State Government for these repairs during 1969-70.
- (e) Investigations are being carried out and steps will be taken to provide increased waterways where necessary.

PROSCRIPTION OF BOOKS, PERIODICALS ETC.

480. SHRI G. GOPINATHAN NAIR: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the names of the periodicals, books and other literature published in India which have been proscribed and the dates on which each of them was proscribed during the current year; and
- (b) the names of the periodicals, books and other literature published abroad which have been proscribed by Government and the dates on which each of them was proscribed during the same year?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) and (b) A statement containing information about books, periodicals etc. published in India and abroad and the provisions of law under which they were declared forfeited by the Central Government and the State Governments/ Union Territory Administrations cept six States and two Union Territories), is laid on the Table of the House. [See Appendix LXVI, Annexure 36]. Information in respect of the remaining States and Union Territories will be laid on the Table of the House in due course. CONSTRUCTION OF OTHER HARBOUR AT VISAKHAPATNAM

481. SHRI B. K. MAHANTI: CHAUDHARY A. MOHAM-MAD:

Will the Minister of TRANSPORT AND SHIPPING be pleased to state:

- (a) whether Government have approved the scheme for the construction of an outer harbour at Visakhapatnam;
- (b) if so, what would be the estimated cost of the project; and
- (c) by when the work at this project is likely to be taken up and by what time the work is likely to be completed?

THE MINISTER OF TRANSPORT AND SHIPPING (PROF. V. K. R. V. RAO): (a) Yes, Sir. The project for the construction of an Outer Harbour at Visakhapatnam Port has been approved in principle.

- (b) The project is estimated to cost about Rs. 31 crores.
- (c) It is not possible to indicate precisely at this stage as to when the project will be taken up for execution and when it will be completed. Consulting Engineers have been appointed by the Visakhapatnam Port Trust to prepare a detailed Project Report on receipt of which a realistic time should for the execution of the product of the drawn up.

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) and (b) The Union Cabinet Secretary and Home Secretary visited NEFA area in the first week of November,

1968. The object of their visit was to acquaint themselves firsthand with various problems of NEFA, such as those relating to development, education and communications, and to have cussions with local official in NEFA Administration so that they may be in a better position to advise the Government of India on matters relating to NEFA that come up from time to time. In the circumstances the question of turnishing details of any report submitted by the Cabinet Secretary and Home Secretary does not arise.

484. SHRI T. SIDDALINGAYA Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that the balk selection of Grade II Stenograpiers under the Central Secretariat 'enographers service to Grade reing done on centralised basis?

- (d) whether it is a fact that more weightage is being given to seniority instead of merit; and if so, the reasons therefor?

THE MINISTER OF STATE THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) Yes, Sir.

(b) to (d) These matters are yet to be finalised.

PROMOTIONS ON BASIS OF MERIT

485. SHRI T. SIDDALINGAYA: Will the Minister of HOME AFFAIRS be pleased to state.

- (a) whether it is a fact that the Prime Minister has been emphasising that the future promotions of departmental candidates should be on the basis of merit and that less weightage should be given to seniority; and
- (b) if so, the action, if any, taken by Government in this direction?

THE MINISTER OF STATE THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) and (b) Promotions to selection posts are made on the basis of merit within a certain field of choice which, whenever possible, should extend to five or six times the number of vacancies expected within a year. If, however, there is an officer of outstanding merit, he may be included in the list of eligibles even if he is outside the normal filed of choice. It has also been decided to apply more rigorously the merit criterion in respect of higher level posts under the Government of India. Promotions to other posts which are not selection posts are made on the basis of seniority subject to rejection of the unfit. In certain posts, promotions are made on the basis of competitive examination limited to departmental candidates the lower grade fulfilling certain criteria of eligibility. There is also a scheme of merit promotion and advance increments for certain scientific and technical staff. Since the existing system already placed the required emphasis on merit, there is no proposal at present to modify it.
