## REHABILITATION OF REFUGEES FROM EAST PAKISTAN IN ASSAM

- 597. SHRI M PURKAYASTHA: Will the Minister of LABOUR AND REHABILITATION be pleased to state:
- (a) the total number of Displaced Persons who entered Assam since the partition up to the new influx of 1964;
- (b) the total number of migrants who entered Assam since 1964 to 31st October, 1968:
- (c) the schemes under which the new migrants will be rehabilitated there; and
- (d) what is the total number of families who are living in different camps of the Assam State?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR, EMPLOYMENT AND REHABILITATION (SHRI D. R. CHAVAN): (a) Approximately 4.92 lakh persons entered Assam from East Pakistan since the partition up to the end of December, 1963

- (b) During the period 1-1-1964 to 27-10-1968, approximately 1.98 lakh persons entered Assam from East Pakistan. Information regarding the number of such migrants who entered Assam after 28-10-1968 is not available yet.
- (c) and (d) New migrants from East Pakistan, who have entered the relief camps are eligible for rehabilitation assistance. So far, nearly 10,000 families have already been resettled. As on 23-11-1968, 6,431 agriculturist and non-agriculturist families were residing in different relief camps in Assam. Schemes for their rehabilitation are under way. In addition, 1,249 families of long term liability category of old, infirm, widows etc. are also in camps and they will be accommodated eventually in P. L. Homes.
