MEETINGS ADDRESSED BY SHBIKH ABDULLAH

133. DR. BHAI MAHAVIR: Will the Minister of HOME AFFAIRS be pleased to state:

(a) the number of public meetings addressed by Sheikh Abdullah, in the State of Jammu and Kashmir since his arrival there;

(b) whether his pronouncements come under the purview of the Prevention of Unlawful Activities Act; and

(c) if so, what steps Government have taken in, the matter?

THE MINISTER OF STATE IN THE MINISTRY Op HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) He has addressed a number of public meetings including wayside gatherings. Government do not have precise information about the number of wayside meetings, but the number of other meetings addressed by him is About 50.

(b) and (c) The Government consider that some of the speeches made by Sheikh Abdullah are objectionable. In Government's view disapproval of uch speeches publicly is the appropriate course at present, and this has been done.
