THE DEPUTY MINISTER IN THE MINISTRY OF WORKS, HOUSING AND SUPPLY (SARDAR IQBAL SINGH): (a) and (b) Yes. Four representations were received from the Junior Proof Readers of the Government of India Presses at Minto Road, and Rashtrapati Bhavan, New Delhi.

(c) and (d) All the representations from the workers in the Reading Branch of Government of India Presses were considered by the Categorisation Committee set up by the Government in 1966 to categorise the workers of the Reading Branches of the Government of India Presses- This Committee considered various representations filed by Unions of workers and individual workers. No separate replies were sent by the Committee to the Unions or individual workers. This Committee has since submitted its report to the Government. The report concerns all the workers of Reading Branch and is now under examination of the Ministry.

THE DEPUTY PRIME MINISTER AND MINISTER OF FINANCE (SHRI MORARJI R. DESAI): (a) Yes, Sir. The Enforcement Directorate searched on 10th November, 1967, the residential premises of Shri R. P. Misra of Air-India at Calcutta.

- (b) A cheque for U. S. \$150 and some documents were seized. The Director of Enforcement, on adjudication, found Shri Misra guilty of contravention of the provisions of the Foreign Exchange Regulation Act, 1947 and imposed a penalty of Rs. 1400 in addition to confiscation of the seized cheque.
- (c) Shri Misra was due for a foreign posting in the normal course and was to be transferred to Paris. However, his transfer has been deferred.
- (d) The residential premises of Mrs. Caroline A. Symonds were also searched on 10th November, 1967 by the Enforcement Directorate.
- (e) Some foreign exchange and documents were seized from Mrs. Symonds. However, since Mr. Symonds wes able to satisfactorily account for the foreign exchange seized, ro case was registered against her and the seized forein exchange was returned to her
