DECREASE IN BIRTH RATES

264. SHRI A. D. MANI: SHRI N. PATRA:

Will the Minister of HEALTH, FAMILY PLANNING AND URBAN DEVELOPMENT be pleased to state:

- (a) whether it is a fact that 1.2 million births have been prevented in 1967 as a result of family planning methods; and
- (b) if so, on what basis this calculation has been arrived at by the Ministry?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH, FAMILY PLANNING AND URBAN DEVELOP. MENT (DR. S. CHANDRASEKHAR): (a) and (b) On the basis of expert demographic study it has been estimated that about 1.3 million births have been prevented in India in 1967 as a result of adoption of various methods of family planning. This calculation is based on the number of sterilization operations caried out and I. U. C Ds inserted in different years upto 1967, and conventional contraceptives distributed during 1967, the age distribution of persons who got sterlized the age specific fertility and the reproductive period of the women.

THE DEPUTY PRIME MINISTER AND MINISTER OF FINANCE (SHRI MORARJI R. DESAI): (a) Yes, Sir.

- (b) The memorandum discusses certain issues relating to the financing of development programmes in Andhra Pradesh and requests for additional Central assistance.
- (c) The matter is under consideration.

SERVICE CONDITION OF EMPLOYEES OF PUBLIC SECTOR UNDERTAKINGS

266. SHRI A. G. KULKARNI: SHRI M. M. DHARIA: SHRI G. R. PATIL:

Will the Minister of FINANCE be pleased to state:

- (a) whether there is any proposal under Government's consideration to formulate uniform service conditions for the employees of public sector undertakings similar to those of the Central Government employees immediately in order to remove hardships being caused at present; and
- (b) if not, what are the reasons therefor?

THE DEPUTY PRIME MINISTER MINISTER AND OF FINANCE (SHRI MORARJI R. DESAI): and (b) The service conditions in respect of Public Enterprises are framed. taking into account the nature of the functions of the enterprises concerned and other relevant factors which admittedly vary from enterprise to enterprise, and also are not necessarily the same as those applicable to Cen-Government employees. ministrative Reforms Commission in their Report on "Public Sector Under\_ takings" was also of the view that alrationalisation should though affected, wherever possible, enforcement of uniformity in the matter of pay, allowances, etc. would not be advisable or practicable. This recommendation, along with other recommendations of the Commission, is now under consideration of Government.
