display of posters praising the Chinese leader, Mao Tse-Tung at various places in Kerala and Calcutta.

- (b) The posters displayed at Calcutta appear to have incited violence and preached Maoism. According to the Government of Kerala, while the posters at Calicut contained sayings said to be of Mao Tse-Tung and praises for the Chinese way of socialism, they contained no incitement to violence.
- (c) No communist propaganda literature printed in China was found in circulation in Calcutta. The Goytrn-ment of Kerala have no information in this regard.
- (d) Mere distribution or display of Mao's posters is not punishable under the existing law but where such dis play constitutes a threat to public peace, appropriate action under law can be taken.

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAiKS (SHRI VIDYA CHARAN SHUKLA): (a) and (b) The Official Languages (Amendment) Act, 1967 does not result in any language burden on the candidates for Central Government Services and posts. Government arc giving thought to the problem of inequality of burden resulting from paragraph 4(a) of the Resolution. Several suggestions are under consideration. Because of the complicated nature of issues involved, various aspects need detailed examination.
