It is reported by the Government of Haryana that on 26th April, 1968 a person driving his scooter had an accident with a Jeep on the Faridabad-Delhi Road. The place of accident was not close to the Police Station. The eye witnesses have stated that the scooter struck the right rear part of the Jeep and the person died instantaneously.

Hence the question of providing first aid to the injured did not arise.1
