## CONFERENCE ON CEASEFIRE IN NAGALAND

- 367. SHRI Y. ADINARAYANA REDDY: Will the PRIME MINISTER be pleased to state:
- (a) whether it is a fact that a | conference of Naga Hostiles on ceasefire observations was held recent ly with the representatives of the Gov ernment of India;
- (b) if so, what decisions were arrived at at the conference; and
- (c) the names of officers who represented the Government of India at the conference?

THE PRIME MINISTER (SHRIMATI INDIRA GANDHI): (a) to (c) A joint Conference under the aegis of the Nagaland Peace Observers' Group was held at Dimapur on 20th April, 1968 in which representatives of Stat.; Government of Nagaland, and Underground Nagas participated.

The Agreement at the Conference mainly cover the following points:—

- (i) Categorical re-assurance that both sides would honour the terms of Agreement on Suspension Of Operations.
- (ii) Underground confirmed that honouring the Agreement also includes an assurance that they (Underground) would not import any arms and ammunition etc. from abroad.
- (iii) To ensure speedy implementations both sides agreed to accept unanimous decisions of the Nagaland

- Peace Observers Group in matters relating to the Agreement on the Suspension of Operations.
- (iv) It was agreed to open two Peace Sub Centre at Mokokchung and Tuensang.
- (v) It was also decided to review the cases of Underground in police custody.
