*241. SHRI M. P. BHARGAVA: f SHRI KRISHAN KANT;

Will the Minister of DEFENCE be pleased to state:

- (a) whether it is a fact that ser vices of Junior Commissioned Officers are not counter for pension benefits on their becoming regular Commis sioned Officers;
- (b) whether any representations have been received from Defence Personnel for counting the total service for pension benefits whether it is as JCOs. or regular commissioned officers by promotion; and
- (c) if the reply to part (b) above be in the affirmative, what action is being taken by Government in the matter?

THE DEPUTY MINISTER IN THE MINISTRY OF DEFENCE (SHRI M. R. KRISHNA): (a) No, Sir, l_n the case of regular officers commissioned from Junior Commissioned Officer rank, service rendered as a Junior Commissioned Officer counts in full for pension as regular officer.

SHRI M. P. BHARGAVA: That has nothing to do with this.

SHRI M. R. KRISHNA: In this connection I may however state that the period of service as J.C.Os. is counted for pension.
