Pension Benefits for J.C.Os.

## \*241. SHRI M. P. BHARGAVA: † SHRI KRISHAN KANT:

Will the Minister of DEFENCE be pleased to state:

- (a) whether it is a fact that services of Junior Commissioned Officers are not counted for pension benefits on their becoming regular Commissioned Officers;
  - (b) whether any representations have been received from Defence Personnel for counting the total service for pension benefits whether it is as JCOs. or regular commissioned officers by promotion; and
  - (c) if the reply to part (b) above be in the affirmative, what action is being taken by Government in the matter?

THE DEPUTY MINISTER IN THE MINISTRY OF DEFENCE (SHRI M. B. KRISHNA): (a) No, Sir. In the case of regular officers commissioned from Junior Commissioned Officer rank, service rendered as a Junior Commissioned Officer counts in full for pension as regular officer.

(b) and (c) Do not arise

SHRI M. R. KRISHNA: There is no representation in the Ministry but probably the Member is thinking of the J.C.Os. who are being promoted to the rank of Emergency Commissioned Officers and Short Service Commissioned Officers.

SHRI M. P. BHARGAVA: That has nothing to do with this.

SHRI M. R. KRISHNA: In this connection I may however state that the period of service as J.C.Os. is counted for pension.
