THE MINISTER OF STATE (DE- : FENCE PRODUCTION) IN THE MINISTRY OF DEFENCE (SHRI L. N. MISHRA): (a) It is true that there is considerable shortage of married accommodation in most of the peace stations and of single ac- | commodation at Delhi/New Delhi. The i Government owned accommodation is supplemented by hired and requisitioned accommodation to the extent possible.

(b) The construction of housing accommodation for Defence personnel has been given high priority, and it is planned to make up the deficiencies according to 'a phased programme of 15 to 20 years from 1965-66 onwards.

(c) No, Sir- Adequate safeguards have been provided to ensure that the accommodation is hired only at fair and reasonable rents consistent with the prevalent market rents. It is, however, true that the rents at some stations are higher than those at other stations.

#### CHINESE RESTRICTIONS ON INDIAN-EMBASSY

395. DR. (MRS) MANGLADEVI TALWAR: Will the PRIME MINISTER be pleased to state:

(a) the nature' of restrictions imposed by the Government of China on the Indian Embassy in Peking; and

(b) what is Government's reaction thereto?

THE PRIME MINISTER (SHRIMATI INDIRA GANDHI): (a) In theory, the Indian Embassy in Peking is subject to the same restrictions as all other resident Missions in Peking. These relate to the movement of personnel, travel, exit and entry into China. However, in practice, it has been found that an obviously discriminatory attitude is taken towards the personnel of the Indian Embassy.

(b) The Government of India observe broad reciprocity in all important respects in accordance with our laws and regulations and international conventions.
