ACTION AGAINST NEWSPAPER PRECHING COMMUNALISM

*244 SHRI ABID ALI: Will the Minister of INFORMATION AND BROADCASTING be pleased to state action taken by Government against newspapers journals which preach communalism and other unsocial activities and how many these have been black-listed for Government advertisements and other facilities?

THE MINISTER OF INFORMA-TION AND BROADCASTING (SHRI K. K. SHAH): Government advertisements are withheld from such newspapers and periodicals as fall the accepted journalistic standards or indulge in virulent propaganda inciting communal passions, or preach violence, or offend socially accepted conventions of public decency and morals, thus undermining the basic national interests. Sixteen newspapers are not being used by the Directorate of Advertising and Visual Publicity for Central Government advertisements in keeping with the above principles. No action has been taken to deny normal facilities provided by the Press Information Bureau to such papers.

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AF-(SHRI B. R. BHAGAT): FAIRS (a) and (b) Yes, Sir. Our Embassy took up the matter with the management of the bank concerned and the management have apologised saying that it was a clerical error. Our Embassy in West Germany, as our Embassies elsewhere, make constant efforts to explain that Jammu and Kashmir is part of India.
