eome exceeds that amount, only the
 excess is chargeable to tax.

(b) The whole of the business income of a co-operative society is exempt from the tax only where it is derived from specified activities, such as banking or providing credit facilities to its members, cottage industry, marketing of the agricultural produce of its members, etc.

In all other cases, such as of housing co-operative societies, urban consumer societies, transport societies, forest labourers' societies, etc., only the first Rs. 15,000 of the business income is exempt from tax. There is no special justification for according a preferential tax treatment to labour contract societies.

## IRRIGATION PLAN FOR UTTAR PRADESH

- 71. SHRI SITARAM JAIPURIA: Will the Minister of IRRIGATION AND POWER be pleased to state:
- (a) whether the Government of India have recently discussed the irrigation plan for Uttar Pradesh for inclusion in the Fourth Five Year Plan; and
- (b) if so, what are the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (PROF. SIDDHESHWAR PRASAD): (a) During his recent visit to Lucknow on the 11th April, 1968, the Union Minister of Irrigation and Power had a general discussion on the Fourth Plan proposals of the Irrigation Department of Uttar Pradesh.

(b) Details are yet to be worked out.

### U.S. AID

- 72. SHRI SITARAM JAIPURIA: Will the Minister of FINANCE be pleased to state:
- (a) whether it is a fact that the Government of U.S. have recently put certain specific conditions on American aid to developing countries;
  - (b) if so, the details thereof; and
- (c) to what extent India is going to be affected by these conditions?

THE DEPUTY PRIME MINISTER AND MINISTER OF FINANCE (SHRI MORARJI R. DESAI); (a) and (b) The foreign aid legislation enacted by the U.S. Congress in 1967 has two new features. One is that it contains provisions which make it incumbent on the U.S. Government to take into account the extent of self-help efforts being made by developing countries before deciding on the quantum of assistance to such countries. The other is that it contains provisions whereby economic aid to developing countries could be affected depending on the view which the U.S. Government takes regarding their defence expenditures.

(c) These provisions are for the U.S. Government to consider and apply, depending on the circumstances of each developing country. No broposal has been received from the U.S. Government affecting aid to India.
