(e) There is no ban on the import of extile machinery not indigenously available *hiid*, subject to foreign exchange being rjrr«ilable, import licences are issued to import such machinery on the basis of the merits of each case.

On a review, export duties on certain varieties ofjute go^is have been reduced with effect from February 7, 1968.
