THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) and (b) The Union Public Seivice Commission are now engaged in the preparatory work necessary for the introduction of the languages mentioned in the Eighth Schedule as alternative media, at the option of the candidates, for the Combined Compe-itive Examination. The necessary staff has been appointed and equipments like typewriters etc. are being secured. Qualifier examiners, preferably having knowledge of more than one lpnguage, are being located.

Both the Government and the Commission are anxious to implement this decision as early as possible. Looking to the progress so far made, Government feel confident of a start being made with the introduction  $_0$ f these languages as optional media for som<sup>\*1</sup> subjects at the Combined Competitiv Examination to be held in 1969.

#### DEVELOPMENT OF MASULIPATAM PORT

(b) There are no rigid criteria laid down by statute for the development of a port into a major port and each case has to be considered on its own merits. Generally speaking, however, criteria to be taken into account will include the magnitude of ocean-going traffic, needing alongside dock of jetty facilities, transport links with the hinterland, volume of investment needed and economics thereot, ana the overall requirements of the country for major port facilities.
