CHINESE TROOPS ON ASSAM BORDER

- •472, SARDAR RAM SINGH: Will the Minister of DEFENCE be pleased to state:
- (a) whether it is a fact that rebel Mizos are getting their supply of arms from the Chinese troops concentrated on the North-Western region of Burma, bordering Assam Hills; and
- (b) if so, what steps have been taken to cut off this supply of arms to the rebel Mizos?

THE MINISTER OF DEFENCE (SARDAR SWARAN SINGH): (a) and (b) The question proceeds on the assumption that Chinese troops are concentrated in the North-Western region of Burma and that Mizo hostiles are receiving arms assistance from them. We have no information to that effect. In so far as prevention of supply of arms to hostile Mizos is concerned, our security forces are making the fullest efforts to prevent the same as far as practicable.
