THE MINISTER OF LABOUR AND REHABILITATION (SHRI JAISUKH-LAL HATHI): (a) Yes Sir. Government's decisions on the recommendations of the first two Wage Boards were announced on the 3rd June, 1967. Decisions on the recommendations of the Coal Wage Board were announced on the 21st July, 1967.

(b) The recommendations of these Wage Boards are not enforceable statutorily. Their implementation is being secured through persuasion and advice by the officers of the Central Industrial Relations Machinery.

DECLINE IN EXPORT OF SUGAR

\*516. SHRI R. P KHAITAN: Will the Minister of FOOD AND AGRI-CULTURE be pleased to state:

(a) whether the export target of sugar for 1968 is even less than half of the target for 1967; and

(b) if so, what are the reasons for this decline in the export of sugar?

THE MINISTER OF STATE IN, THE MINISTRY OF FOOD, AGRI-CULTURE, COMMUNITY DEVELOP-MENT AND CO-OPERATION (SHRI ANNASAHEB SHINDE): (a) Yes, Sir,

(b) Reduced availability of sugar during the current year 1967-68.

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR, EMPLOY-MENT AND REHABILITATION (SHRI S C. JAMIR): (a) Out of 176

Recommendations, 12 are in the pature of Conclusions and Opinions which have been noted; 115 have been accepted either fully or with modification<sub>s</sub> or in principl; the remaining 49 Recommendations are under consideration.

PROCUREMENT OF FOODGRAINS

\*518. SARDAR RAM SINGH: Will the Minister of FOOD AND AGRI-CULTURE be pleased to state:

(a) the total quantity of foodgrains expected to be procured by the Food Corporation of India during the kharif season;

(b) how the State Governments have reacted to the proposed procurement and the prices to be paid to the producers; and

(c) what is the anticipated quantity of food to be imported from abroad during the current year to meet the country's requirements?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AGRI-DEVE COMMUNITY CULTURE. **COOPERATION** AND LOPMENT (SHRI ANNASAHEB SHINDE). (a) The target fixed for the Food Corparation of India for procurement of food the kharif crop year grains during 1967-68 is 37.67 lakh tonnes.

(b) The State Governments have been aware of the paramount need of Internal procurement. The procurement prices of kharif cereals have been fixed by the Government of Ind<sub>1a</sub> in consultation with the State Governments.

(c) The anticipated imports during 1968 has been estimated as 7.5 million tonnes.
