

STATEMENT

Proposed terms of reference of the Irrigation Commission

1. To review the development of irrigation in India since 1903 and report on the contribution made by Irrigation to increasing the productivity of land and/or providing insurance against the vagaries of rainfall.

2. To examine in detail the irrigation facilities available in chronically drought affected areas and suggest essential and minimum irrigation works to be undertaken promptly in such areas.

3. To draw up a broad outline of development of irrigation of all types for achieving self-sufficiency in cereals.

4. To examine the administrative and organisational set-up for the planning, execution and operation of irrigation works, particularly with a view to the speedy completion of projects and reduction of their gestation period.

5. To suggest criteria for the sanction of irrigation projects ;

6. To examine any other matter incidental or related to the development of irrigation in the country and make suitable recommendations.

ALLOTMENT OF GOVERNMENT ACCOMMODATION

(b) whether rules permit allotment of Government accommodation to married daughters of retiring officials even when they are government employees?

THE DEPUTY MINISTER IN THE MINISTRY OF WORKS, HOUSING AND SUPPLY (SARDAR IQBAL SINGH):

(a) and (b) After the retirement of a Station Engineer, All India Radio on 30th November, 1966 the allotment of residence in his occupation was cancelled from his name with effect from 1st February, 1967. He was, however, allowed to retain the residence on market rent (Rs. 274-60) per month against normal rent (Rs. 62-45) till 15th October, 1967. The residence was further allotted temporarily for a period of six months on payment of market

rent in the name of his married daughter who is an employee of the Council of Scientific and Industrial Research.
