ing the last year has increased its fare and tariff rates; and

(c) whether any steps are being taken by Government in regard to the efficient functioning of the Indian Airlines?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) Indian Airlines showed a loss of Rs. 423.50 lakhs after making a provision of Rs. 140 lakhs towards Development Rebate Reserve.

(b) The fares were increased only from 1-8-1967, *i.e.*, after the end of the financial year 1966-67.

(c) Various measures such as augmentation of capacity on the trunk routes, and modernisation of the fleet by replacement of uneconomic aircraft, are under consideration.
