SHRITIRATH RAM AMLA:

Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

- (a) whether it is a fact that the Jammu airport is unfit for the landing of Viscounts and Caravelles; and
- (b) if so, what steps Government propose to take to make it fit for the landing of such heavy aircraft?

THE MINISTER OF TOURISM AND AVIATION CIVIL KARAN SINGH): (a) and (b) The aerodrome at Jammu is owned and maintained by the Air Force, and a proposal to make it fit for Viscount operations is under consideration in consultation with the Ministry of Defence. There is no proposal at present to introduce Caravelle service there.
