## •181. SHRI A. D. MANI:f SHRI M. RUTHNASWAMY:

Will the Minister of HOME AFFAIRS be pleased to state:

- (s) whether Central Government's advice was sought by the Chief Minister of Assam before he took the decision to arm loyal Mizos; and
- (b) if so, what will be the nature of supervision which will be exercised by Government of India to prevent misuse of such arms?

THE MINISTER OF HOME AFFAIRS (I3HRI Y. B. CHAVAN): (a) Yes.

- (b) It has been impressed upon all concerneil that while implementing the scheme there should be strict vigilance in selection of volunteers and constant supervision and close association of the security forces.
- SHRI A. I). MANI: May I ask the Minister of Home Affairs whether he has examined the 'question" of the principle of arming loyal people against disloyal people? Suppose a request of this kind is made in Kashmir that loyal Kashmiris should be armed against disloyal Kashmiris, would the Government of India give permission to such move from the Kashmir Government?
- SHRI Y. 13. CHAVAN: The hon. Member, if ] may take your permission to say so, puts hypothetical que:tions and I am not going to answer hypothetical questions.

SHRI A. D. MANI: Since he is giving this privilege of arming loval Mizos, may I know whether he has accepted this principle of a volunteer force being organised in the country? Such a volunteer force might be

serious law and order problem later on. Has the Government considered this matter in all its implications, and may I ask him further what is the vigilance machinery which he is going to set up for checking who is a loval Mizo and who is a disloyal Mizo?

SHRI Y. B. CHAVAN: I have not stated whether it should be given to loyal or disloyal people, but naturally arms will be given to those people who are going to make proper use of it. Does he expect me to give arms to people who will make use of them against the Government itself? What is the purpose and what does he want us to do?

SHRI M. RUTHNASWAMY: Were these arms transmitted through the Central Government or were directly given to the local Government?

SHRI Y. B. CHAVAN: How can the Central Government do it? Naturally it has to be given through the local officers there.

It is a fact that a large number of people have taken to arms. We have to depend upon there support and we have to organise their support. There is nothing wrong in this-

SHRI K. P. MALLIKARJUNUDU: It has been reported in the papers that towards the end of last year certain Mizos, along with certain rebel Nagas, were proceeding to Pakistan for securing arms and they were intercepted toy our Border Security Force and some action was taken. May I know how many people were involved, how many persons were arrested and what action did the Government take in that behalf?

SHRI Y. B. CHAVAN: A large number of encounters have taken place between the Mizo hostiles and the Security Forces. I do not know exactly to what particular event the hon. Member is referring. If he will give me notice, possibly I can give him some more details.

SHRI DALPAT SINGH: May I know from the Home Minister what information he has about the number of hostile Mizos and whether our Security Forces in the area are adequate or not?

SHRI Y. B. CHAVAN: I do not want to give the exact number of the Security Forces which are functioning there. As far as the number of the hostiles is concerned, it keeps on varying. Those who go underground sometimes come above to do their normal work. It is a varying thing. Of course, I cannot be expected to give the number of our Forces working there.
