**THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA):**

(a) to (c) A post of O. S. D. (Border) had been created on 25th February, 1966 by the Government of Himachal Pradesh with the approval of the Government of India. An officer of the Central Government was appointed to this post on the 28th February, 1966. On his transfer, the Government of Himachal Pradesh appointed a Military officer to the post and designated him as O. S. D. (Border)-cum-Military Secretary. There has been only a change of designation for a post which already existed.

**AGE OF RETIREMENT OF STATE GOVERNMENT EMPLOYEES**

**378. SHRI B. K. MOHANTI:

(a) the names of the States which have reduced the retirement age of their employees in their respective states;

(b) whether the Central Government also propose to reduce the retirement age of their employees; and

(c) if not, the reasons therefor?

**THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA):**

(a) Kerala, Madhya Pradesh and Rajasthan. (The age of retirement of Kerala State Government employees was raised from 55 to 58 only during

1966, but it was again reduced to 55 in 1967).

(b) No, Sir.

(c) The age of superannuation of Central Government employees was raised from 55 to 58 only a few years ago after a thorough examination of all relevant factors. The circumstances have not changed to warrant reconsideration of this decision.
